2. SUPREME COURT OF CANADA

SCC allows for more dangerous offender assessments

The Supreme Court of Canada today made it easier for Crown prosecutors to apply for assessment under the dangerous offender and long-term offender provisions — potentially allowing more criminals to be held for indeterminate sentences.

Supreme Court of Canada to tackle aboriginal representation on juries

A landmark case headed to the Supreme Court of Canada Monday dealing with aboriginal representation on juries in criminal trials, began with some pushing and shoving on a First Nation reserve in Kenora — and ended in bloodshed.

R. v. Conception 2014 SCC 60 October 3, 2014

Mental disorder — Dispositions by a court or review board — Treatment disposition — Accused declared unfit to stand trial — Hearing judge issuing a "forthwith" treatment order without consent of treating hospital — Whether a court may make a disposition order directing that treatment begin immediately even though the hospital or treating physician does not consent to that disposition — Whether the consent requirement relates to the timing of carrying out the order or just to the treatment itself

Right to life, liberty and security of the person — Criminal law — Mental disorder — Treatment disposition — Whether requiring hospital's consent for all provisions of the treatment disposition would infringe accused's right to procedural fairness — Whether treatment disposition provisions of Criminal Code are unconstitutionally vague or arbitrary

3. AMERICAN LAW

Dzhokhar Tsarnaev's Friend and The 'High Out of His Mind' Defense

Robel Phillipos, the friend of accused Boston Marathon bomber Dzhokhar Tsarnaev who allegedly obstructed the investigation into the 2013 attack, is arguing that he was too high to lie to authorities. It does not look like anyone was impressed.

Kenyan president Uhuru Kenyatta becomes first serving head of state to face International Criminal Court

Lawyers for Kenyan president Uhuru Kenyatta say prosecutors at the International Criminal Court have failed to prove their case against him, on the first day of a three-day hearing at The Hague.
